Membership Dues/Fees/Assessments and Religious School Tuition

Membership Dues, Fees and Assessments are due on **July 1st** of each year.

As a courtesy and for reasons of hardship, we allow for payment plans, payment by credit card, and requests for reductions (see section below). There are a number of payment options outlined in the Payment Plan Form. ***Please return the completed Payment Plan form as soon as possible advising us of the payment plan you have selected.***

In accordance with our By-laws, Religious School Tuition becomes due upon registration and must be paid as follows: 50% before the first day school begins in the fall, and 100% on or before December 31st. Exceptions are allowed if you have selected a payment plan that extends beyond the end of the current year.

The Temple subsidizes our Religious School students; please consider an additional contribution if you are able.

B'nai Mitzvah Fees

50% of the fee must be paid one (1) month before tutoring begins.

100% of the fee must be paid two (2) months before the B'nai Mitzvah date.

Temple Beth David may bill you up to two years in advance for an upcoming Bar/Bat Mitzvah to allow you additional time. It is our policy not to provide adjustments or reductions to this fee.

Credit Card Payment

We accept Visa and MasterCard. See the *Payment Plan* form for details. Temple Beth David will incur a 3% transaction fee to process credit card payments; please consider including this amount as part of your payment. **Credit card information must be renewed annually at the beginning of each fiscal year.**

Reduction Requests - Membership Dues, Fees, Assessments and Tuition Abatement

For reasons of hardship, you may request a reduction of Temple dues, fees, assessments and/or Religious School tuition and fees. Please complete a *Confidential Application for Dues and Tuition Reduction* form which must be submitted to the attention of the Temple President and delivered to the Temple office by July 31st (allowances are made for extenuating circumstances). These forms are available at the Temple office and **must be renewed each year**. Building Fund and B'nai Mitzvah fees cannot be adjusted; however, upon request the Building Fund can be deferred to the following year. For questions or further information, you may contact the President or Financial Secretary. All requests are confidential.

Passport to Israel Program (not currently open to new participants)

All membership dues, fees, assessments, and/or other financial commitments and your contribution must be paid in full before a matching contribution will be made by the Temple.

When writing checks

Write your Family ID (found on your invoice) in the memo section; do not staple checks to any forms.

Resignation

We hope you will be part of our Temple family for many years to come. If you wish to resign, please submit notice to the Temple President by July 1st. Upon resignation, all dues, fees, and/or assessments, which have already accrued or are outstanding from preceding years prior to the effective date of the resignation are still payable to the Temple.
